

INSURANCE & PRODUCT INFORMATION

**All Avis cars are insured according to local legal demands.
A non-waivable excess charge applies in connection with damage or theft.
Avis offers the following to supply, reduce/cover the liability.**

Avis terminology and abbreviations:

CDW/CDI	Collision Damage Waiver Insurance
SCDW	Super Collision Damage Waiver/Insurance
TP	Theft Protection
STP	Super Theft Protection
LDW	Loss Damage Waiver/Insurance (Available in e.g. USA and Canada)
LI	Liability Insurance
ALI	Additional Liability Insurance (Available in e.g. USA and Canada)
PEP	Personal Effects Protection
PAI	Personal Accident Insurance
SPAI	Super Personal Accident Insurance
RSN	Roadside Assistance

Collision Damage Waiver/Insurance – CDW/CDI (Included in most rates)

Reduction of customer liability in case of damage to the car.

Super Collision Damage Waiver/Insurance – SCDW/SCDI

Excess reduction cover. Reduces customers liability, in some countries reduced to zero.
Windscreen and tires are not covered in most countries
Normally sold as a package together with Super Theft Protection.

Theft Protection – TP (Included in most rates)

Reduction of customers liability in case of theft of the car or its equipment.

Super Theft Protection – STP

Excess reduction cover. The Customers will have reduced liability.
Normally sold as a package together with Super Collision Damage Waiver.

Loss Damage Waiver - LDW

Acceptance of LDW relieves the renter and authorized additional drivers of responsibility for loss of, or damage to the Avis car

Liability Insurance – LI

Liability Insurance covers replacement or repair of the car's exterior windows in the event of damage to the window due to sudden impact.

Additional Liability Insurance - ALI

Additional liability insurance covers in the event of damage to third party.

Personal Property Cover - PEP

Personal property covers in the event of loss or damage to the driver and immediate family's property during the lease.

Personal accident insurance - PAI

Personal accident insurance covers in the event of death and physical injury to the driver and fellow passengers while driving the car.



Super Personal Accident Insurance – SPAI

Super personal accident insurance covers in the event of death and physical injury to the driver and fellow passengers while driving the car. Including baggage and cargo insurance of up to a maximum specific amount per single object in connection with a traffic accident.

Special valuables such as jewelry, video equipment and cash will not be covered.

Roadside Safety Net - RSN

Roadside assistance in case of the need for assistance with changing tires, dead car battery, keys locked inside the car.

Fuel

The car is always delivered with a full tank.

As fuel is not included in the price, we therefore recommend that you fill the tank yourself as close to the Avis rental station as possible, before check-in.

Alternatively you can buy a tank of fuel in advance, when you check-out the car.

If you fail to deliver the car with a full tank and have not bought the Fuel Up Front in advance, Avis fills up the car and will also charge a service fee.

Electricity

The car is always delivered with full batteries.

If the car is returned without fully charged batteries a fee will be charged.

Airport charges - Local tax

Mandatory country airport tax that Avis settles with the local authorities.

GPS

Reliable, user-friendly Garmin navigation systems - GPS developed by Garmin for navigation, restaurant, hotel and sights information, 911 emergency calls, etc.

Additional driver

All expected drivers of the rental car must always be registered on the lease.

Minimum age

The minimum age of the driver is 19 years for most car groups, otherwise will be specified.

If the driver is under 25 there is a Young driver fee.

Kilometer/Mileage

Included kilometers is stated at the time of booking.

In case of kilometer limitation, the price per. extra km. is stated as well.

All prices and conditions are provided locally by Avis Rental station and may vary and to only be available in some countries.

Always remember to read the rental agreement – lease contract, carefully before signing.

If a contract is signed the agreement is binding and legally valid, regardless of any oral information.

On the signed lease all purchases and their prices, will always be specified.
